1. Call Meeting to Order – Meeting called to order by Cameron at 6:06 P.M.

Few additional notes:

• It can be used to run tournaments

- It also has 2 courts to enable ADA players with extended space on the sides on these courts
- Facility will have entry plaza and pickleball pavilion
- It has shaded space where booths or stalls can be setup
- Large extended covered area for people to stand and watch the game
- Glass walls around the courts
- Rotating door to enter the courts
- It would have air structure a.k.a bubble structure that will be inflated during fall and winter season. And this would be deflated during the summer season.
- A bubble structure and noise often gets echoed in this bubble structure and noise may be more especially with 12 courts inside this bubble structure. Would this be an issue?
 - Tim: There are multiple facilities that have multiple courts within a single bubble structure. There are enhanced balls available to absorb noise and such.
- Would there be any issue with parking? Generally, we have parking issues during peak hours at THPRD facilities
 - Tim: This issue has already been factored in with the planning. It has enough
 parking spaces and there are nearby soccer fields that also have additional
 parking lots that are typically not used most of the time. So, it should be
 manageable.
- Why are the ADA courts not done on either side (current plan shows it in the second bank)?
 - Tim/Jim: It has been moved across different positions through the planning process. Current position is this second bank. And it was done considering different other logistics in the facility to make it easier for hosting bigger events or tournaments.
- Timeline of the closure of this project: about 2 years from now
 - Presentation by Tim and Jim was wrapped up at 6:37 PM
 - Update on Challenge Grant

We are marching closer towards the due date for the submission

Due date: September 1st

Review with the advisory committee will happen in October Implementation of this project will be done in June 2025

- Execution plan
 - Typically takes about 2 weeks to write the plan and submit
- Projects: James led the discussion
 - Easy option: Take last year's proposal (induction stove) and deploy it in additional facility such as Conestoga
 - Opened the floor for additional ideas
 - Shade structure: Typically such projects will go beyond the grant money
 - Rock climbing: Materials itself would come under 8000\$ to 9000\$ and potentially go out of the budget including the installation cost
 - Question from James: Would there be any adjustment to this budget amount adjusting to inflation?

Cameron: Agreed to bring it up with the management team and see if this can be adjusted next vear

Question from Shalini: Is Cedar hills using the induction stove for cooking classes?

James: Yes and it is installed in the kitchen

 - James requested Cameron to queue up the next year's project discussion in October meeting
 - Final decision on the project for this year: induction cooktop project
